Breeders code of ethics guideline.

This breeders code of ethics guideline adapted and excepted by Manjaro kennels to ensure that Manjaro's **APBT Bulldogs** and puppies are properlycared for, treated appropriately, and not bred or managed in such a way that might harm any of the dogs involved or the APBT Bulldog breed.

Manjaro's will provide the appropriate hygienic accommodation, food, water, and exercise for any dog we are responsible for, looking after, whether this is breeding stock or not, and will ensure that they see the Vet as appropriate when and if this is necessary.

We do not offer any pups with a definite conformation defect – <u>teeth</u> <u>will be functional as for a working dogs bite</u> and will not offer puppies with a problematic hernia.

We also agree to abide with a Vet's recommendation regarding future breeding with a bitch dog that had a prolapse or a cesarean.

Any puppies that are healthy, but that do not conform to the breed standard or otherwise, and are not considered by to be of good breeding quality, but could be provided with an appropriate home, we will note such on documentation if such a dog is sold, placed, or offered a home. Additionally, Manjaro **APBT Bulldog** kennel does not dock tails or crop ears and will not offer such services or advice.

Manjaro APBT Bulldog kennels is committed to abide by the Animal Welfare Act of South Africa and or municipal By-laws.

We will not knowingly breed a dog or bitch dog in any way that <u>could be</u> harmful to the dogs involved, or the **APBT Bulldog** breed as a whole –

relating to dogs with certain types of conformation defects or dogs outside the APBT as Bulldog breed standard.

As breeder and dog owner, <u>we will prevent</u> our confined and kenneled dogs in any possible way to never roam or stray, or otherwise make a nuisance of themselves to other people, including offer people carrying out official duties safely inside our kennel premises - <u>safe entrance on a set per-appointment</u> with necessary documentation of purpose.

Dogs at Manjaro kennel will always wear appropriate collars and be kept under control, **safely confined** (and or on a leach as appropriate) in the hands of trained staff or house family - when away from their kennel or in such times away from home.

When it comes to selling dogs and puppies, a sale would only be made if Manjaro's **reasonably expects** that the pup in question will lead a safe, healthy and happy life.

<u>Know this</u> >>> that it would be as their permeant new home, and that pups or dogs offered <u>will not be used for any illegal purposes</u>.

Buyers accept this stipulation in our puppy sale agreement as read and agreed – because it is freely available on this website, by E mail and or Facebook – know that even if the agreementwas not signed you will still be held accountable and responsible to all stipulated clauses.

Manjaro's will always be available in sharing factual info relating to "Come to know this breed, feeding and common diseases - guidance on other aspects of care and responsible dog ownership and more" – will also will be available to be contacted any time to assist with any questions regarding **APBT Bulldogs** and will assist with possible later re homing if the buyer's circumstances change – except for any transport cost ...that will be to the account of the owner.

When a dog or puppy is sold or otherwise, Manjaro's will provide information to the new owner how to re-register the dog with the **SADBA** registry as new owner, or if paperwork is not available at the time, will agree in writing to send the appropriate paperwork by courier on as soon as possible - this can happen.

Manjaro's will not sell dogs to a commercial wholesaler, retail pet dealer (like a pet shop or a middleman) or allow any dog to be given away <u>as a prize or award in any competition, raffle or contest.</u>

Manjaro's will not issue falsified registration certificates for any given dog (which indicate a dog's pedigree status, registration and identifying information).
