Registering and your APBT Bulldog puppy or dog. About registration on the new owner's name.

Sometimes only online pedigree registration is offered.

Today within "some" APBT Bulldog circles, then with "some" APBT Bulldog fanciers and even "some" breeders as well... they only register their dogs and sometimes offspring on an internet online database". This then can and do cause problems for the new owner to register such a pup with a legitimate registered South African APBT Bulldog registration or association and more so if some dogs in that online pedigree also was nor registered before, it might then become **impossible** to obtain a legal pedigree registration (this is especially important if you a registered breeder).

For "some" – this is understandable - that this is their choice, and they maintain that a pedigree registration with an accepted APBT Bulldog registration does not make the dog – or make them more dog. Then of course it might stand to reason as for "the safety aspect for that dog's owner or the breeder's identity – understandable then "some" might have problems with that" – especially because of the ban of APBT Bulldogs in some countries or unfair municipal and SPCA by laws in some residential areas.

Also understandable for "some" – that do register their dogs and offspring, then for the privilege to breed or compete with, the APBT Bulldog as sporting dog today in organized APBT Bulldog ability and a various dog sport shows or in other disciplines where a pedigree registration document is required.

Then again, these APBT dogs shows have problems today with pulling and or long hang with their dogs.

The same goes for micro-chipping.

Then owners' information that then will become public knowledge - then reflecting the purebred status and thus the dog's and owners' identity and physical address, and or the performance of the dog at hand, and a clear registration of the ancestors of that specific dog's family tree. Also realizing the practice of "some breeders and dog owners" to not to

reveal their dog's specific breeding for other opposition owners and breeders to know how the dog bloodlines was put together.

From "some" breeder's viewpoint – and then "most new owners" also by choice - they proud themselves with the pedigree registration and affiliation with a registry or club.

The also proud themselves as to their dog's family tree - the ancestors' bloodlines of the dogs in the pedigree – knowing the possibility to breed and register their pups to be pedigreed with a legal accepted registry of their choice.

<u>Then to know</u> >>> the APBT Bulldog is not an accepted breed in South Africa - with KUSA, and therefore we have no legal right to stand on. Even Municipal By laws are politicized and APBT Bulldog owners have no legal right to stand on.

Knowledgeable APBT Bulldog breeders know very well that this information regarding proven dogs and bloodlines in the pedigrees are then mostimportant and useful in any breeding programs.

At Manjaro Kennels all our meticulously selected pure bred and top sought after by choice bloodlines and performance proven registered American Pit Bulldogs breeding dogs in the pedigree (bred from no fear never give up attitude, proven workable temperament and from best local sporting working and **registered pedigree bloodline combination dogs**) and then the puppies bred are proudly registered with the SADBA (South African Dog Breeders association) or other.

As a registered breeder I am also a breeder registered at the APBT game Bulldog on "Game dog pedigree" online registration database and all my dogs will be and are traceable.

<u>But as said</u> >>> it is also a well-known fact that some well-known and respected breeders of excellent purebred sporting APBT Bulldogs <u>do not register pups</u>.

Some might only give a handwritten pedigree or a kennel pedigree – then

it might be necessary to trace and register the linage of such a pup (if it is your – the new owners intention for whatever the reason).

The SADBA affiliated with the ADBA is the first legitimate registered registering body for "real "purebred APBT Bulldogs game sporting dogs in South Africa.

You as possible new owner of any Manjaro pup or dog will be handed a SADBA registration pedigree document with purchasing a Manjaro bred APBT Bulldog as sporting dog or puppy.

You can also pursue the breeding dog's test pedigrees before the purchase on Manjaro's Website www.pitbullsa.co.za or as advertised on my Facebook page or Website or on request from me via E male and you will also find these pedigrees on most of the other on line "Game dog pedigrees data base" via the internet.

You can also (recommended) re-register ownership of your Manjaro Bulldog pup with the SADBA or any other registration body of your choice – then using the original given registered litter SADBA pedigree registration.

Some show APBT Bulldog affiliations only allow their members to use a specific registry – why? I don't know.

Looking at the role of the SADBA registration body in South Africa.

Firstly, as an accurate stud book, and registry all members breeding's done and sold to who it is essential for breeders who carefully plan breeding's and is diligent in the selection of quality brood stock – as well as have record to fall back on.

Without a true pedigree (family tree) behind the breeding dogs, there would be no way to predict what type of offspring excellence to expected to be produced and/or assure that quality pure bred APBT Bulldogs might be produced for the future.

<u>Know this</u> >>>-every registration office throughout time has had to rely on the integrity of the breeders who submit paperwork into the office for the accuracy of the studbook.

From my viewpoint, registration is as important for any purebred dogbreed

to track the validity of the purebred status.

At Manjaro APBT Bulldog kennel - our mission is to protect and preserve the "real...like yesteryear APBT Bulldogs in its original form"—game bred working sporting and family dogs.

With typical and genetical unreal friendly human temperament- as workable temperament and willingness -no mix breeding, no bully breeds, no merle or blue-pits or no overly white bred dogs —therefore all breeding done within the APBT Bulldog breed standard at Manjaro's.

Then by registration of all breeding's and with relevant full health tested parent and registered pedigrees... there by guarantee theirpurebred status. Having such an animal "registered" is a stamp of approval from the APBT Bulldogs registration body that the breeder has fulfilled the requirements in record keeping, transferring ownership possibilities and the pedigree can be deemed accurate.

If a registry strictly "in it for the money generated" has little or no requirements or integrity, and allows any dog rescued from the any dog pound, stolen or be it "look -alike pit-bull" to be registered (even open pedigrees) for a fee means very little if not nothing!

A registration body purpose is to strife that your registration will be genuine and to mean something (for "some" with pride means everything) and you can be sure that when you register with the SADBA your pedigrees are safe from tampering with your registration.

The SADBA also reserves the right to void (and they do) these pedigree registrations at any time, in the event of fraudulent application and / or by protest of the purebred status or illegal claimed ownership is proven.
