The importance of a clear studding agreement.

This will prevent any after breeding problems like ... he said ---- I said.

Even this the agreement was not signed ... for whatever the reason the agreement will still be considered valid because Manjaro's display this agreement on www.pitbullsa.co.za and will on request E mail it to the potential breeder or dog owner before the any breeding will take place. This agreement thus reached will then be a binding document and must be dated and signed by both parties before the breeding takes place.

Price if the owner of the stud is going to charge a fee.

A reasonable kennel studding fee at Manjaro's will be R3500.00 - R5000.00, stud fee to be paid upfront - in full before mating take place (if other agreements be considered instead of the cash payment for the studding service – it will be added in writing as an addendum and signed as so to this studding contract).

If an agreement was reached that any puppies from the breeding will become part of the agreement, the owner of the bitch dog **hereby agree that the said pup or pups from the breeding for Manjaro's - from a Manjaro's stud, be registered on Manjaro Kennels name.**

Know this from the start – by breeding any bitch with your stud dog - **you the owner of the stud** allow the registered owner of the bitch to be acknowledged as the breeder of the resulting pups.

This said, the stud dog and registered owner of the stud dog will be registered as the Sire of the pups (without changing the stud dog or the owner of the stud dog's register name) and will be acknowledged as such on the puppies' pedigrees – by any chosen registry.

If the owner of the stud dog needs to prepare accommodation for the bitch dog and if a kennel fee is to be charged by the breeding stud kennel ...it will be decided on beforehand.

If agreed to, beforehand, this needs to be clear before any breeding will take place and a set date and set time agreed to when the breeding can be accommodated by the studding kennel.

The breeding with a Manjaro stud dog **will only take place at Manjaro kennels or where the male studdog is standing.**

The owner of the female dog will have to travel on their owners expenses to the stud dog.

Studding kennel certification will be available for registering puppies to be.

Proof of female and stud dog's pedigree (registration) will be needed and given.

The Dam and the Stud's pedigrees might be required as by both parties' arrangements and expected beforehand.

Breeding agreement and specific requirement relating to the health of the dogs.

This must be agreed by both parties - signed and dated on this agreement beforehand.

The determination of the correct day for successful mating.

This will be on onus of the owner of the female dog – normally on the 10-13th day after first blood.

Handling dogs during the mating.

Please know >>> the owner or his representative need to bring a pair of tough elbow length leather groves and a solid muzzle that properly and safely fits his female dog.

Manjaro's will be indemnified from any bite incident during your time spend breeding your dog at Manjaro Kernel or at the place the breeding will take place if so arranged.

The owner or his representative of the female (must also bring his own breaking stick and be capable to use the breaking stick as well as a sturdy collar with welded D-ring that fit, and a solid APBT Bulldog approved leach - all applicable for an adult APBT Bulldog), these should be offered by the owner of the bitch dog prior to the breeding and accepted by the owner of the stud dog.

The owner of the stud will guarantee experienced Kennel help during the processes of the breeding.

The owner of the bitch dog or their representative should have an "experience helper" available for attending to the mating and the female dog.

Manjaro kennel as well as the owner of the female or his representative please note.

Know this >>> although the female can drink water after the breeding – do not let her relieve herself for an hour or even 2 hours if possible – this to make sure all reasonable efforts has been covered to ensure a successful pregnancy.

Time “for the breeding date” allocated by Manjaro kennels or his representative for your appointment day.

First day of arrival – then only **at daylight hours between summertime +- 07h00 –1700 – wintertime 08h00 – 17h00.**

The opportunity for a second knotting will be part of any agreement, “then on the same day of arranged breeding”.

In the case that the breeding is unsuccessful for whatever the reason.

When, for whatever reason - if the breeding is unsuccessful, the owner of the female dog hereby agrees that the studding contractual agreement obligation from the owner of the stud dog, has been served and **no refund for stud fee will be offered.**

Kennel overnight accommodation and feeding for the female dog at Manjaro's kennel or at the place the breeding is offered and should beforehand be arranged and approved – when needed, for whatever the reason, then at an additional cost of R 40.00 per night and paid-up front

-then for as long as the owner of the female dog is prepared to prolong the possibility of the mating.

If not possible for such accommodation >>> the owner of the female dog should make his own arrangement, for accommodation for him and his dog if so needed.

**Prove of breeding in presence of both breeding's dog parties-
please note.**

The interested breeder or handler of the female will be expected to be present during the mating – with Manjaro's - no breeding will otherwise be done – (unless this clause are otherwise worded in the addendum of this contract – the on mutual trust}, photos will be taken as proof and given for obvious reasons.

Please know this >>> pregnancy without a tie may result – this by informing Manjaro's – mutual trust.

The pickup of female dog at end of agreed matting “day”.

It will be expected from the owner of the female dog and or his handler – it will be his responsibility to pick up the female dog in question or arrange for the picking up the female dog in question >>> after the end of the “agreed set mating day” or sooner as agreed upon - as arranged (then during the agreed said daylight hours - not later than 17h00).

If the female dog in question is not picked up – (for whatever the reason).

Then, within 24h from deadline, after the arranged mating date or days - as the mutual pre agreed date or agreed period - the female dog will then be considered abandoned – then by knowing this the owner of the female dog - in this case automatically herewith give the right to the stud breeding kennel to disperse of the female dog in question - in any way deems fit - with no compensation to the owner of the female dog and any moneys paid will be nonrefundable.

Staying in telephone contact during the breeding operation will be a priority for the owner of the female dog.

The owner of the female dog hereby then agrees and will be responsible to contact the studs breeding kennel – stay in touch, and this would not be expected from the studs breeding kennel to contact the owner of the

female dog for obvious reasons.

Please note – then not to be disappointed!

For the owner of the female dog.

The female dogs last vaccination still to be valid pertaining the date of birth and raising of the forthcoming of the female dog's litter.

Prove of worming that must be done on the first day of bleeding - this is mandatory – prove hereof with certified documentation will be needed by the owner of the stud before breeding.

Vet health certification signed and dated will be needed upfront by the owner of the stud also from the female dog's owner for obvious reasons.

Both parties might be required to produce this documentation before the breeding take place - all certification - dated and stamped from a licensed Vet and should also pertinently indicate >>> a negative for Brucellosis, Babaria, Mange, Herpes and a clean bill for no fleas.

Then normally both parties - **in their preparation period before the planned mating (+- 4 months – will have ample time to comply to this agreement)**, and will then have the opportunity and responsibility to timeously obtain and produce all health & blood test results and medical Vet exam certificates mentioned above - to be handed to both parties up front.

(Please see related articles on this Manjaro's Website Chapter 5 >>> regarding above mentioned health certifications and possible infections.)

It will be to your advantage to come to know about Brucellosis, Mange, Babaria, Herpes before you breed.

Attempted treatment of **Brucellosis** can mask – or to mask diagnostic testing readings and has been shown to yet be another important contributing factor in the spread of this disease.

No flea infested animal would be accepted by the stud breeding kennel. Don't be offended (please arrange a fresh health clearance certification dated as asked for above 5 days prior to the breeding date.)

The stud breeding kennel then reserves the right to contact your Vet in question or have their Vet contact your Vet if in any doubt, after seeing

thedog in question, of then could decline the offer for breeding your dog.

Female dogs over 4 years of age should have a CBC/chem./u/a/UPC

that will tell your veterinarian if your bitch dog has an unusual number of erythrocytes (anemia, polycythemia), leukocytes (leukopenia, leukocytosis), or platelets (thrombocytopenia).

A chemistry panel (blood chem, chemistry screen), also tests kidney function, liver function, electrolyte levels, etc.

Please read worldwide remarks by breeders about Brucellosis >>>

"Canine Brucellosis"

Anyone dealt with this? Is there a treatment? What are the symptoms & procedures if Brucellosis invade your breeding kennel?

Mick Foley >>> If your female or stud dog get it, might as well put them down no cure.

If u bred a male to a few females and the females abort the pups u probably got it but to be sure have blood work done before breeding.

Amanda Clanin >>> That's a very bad one.

Many states require immediate euthanasia of all dogs in your whole yard if one dog tests positive, due to it also being canine to human transmissible - that would be so terrible.

No cure, and contagious through breeding, urine, etc.

It's been popping up a lot because of rescues bringing foreign "rescue" dogs to the States without proper quatrain and testing tine protocols.

Whitney Weston >>> In Canada if you have a dog diagnosed with this you are required to euthanize **your entire yard**.

It is zoonotic - transfers to humans.

Tony Mardones >>> It cost me a ton of money and didn't get good results.

it's a bad deal and if you got a yard full you need them checked too.

Michael Frost >>> Unfortunately, you'll have to put the dog down. Never delt with it myself but, friend of mine got a dog who had it and ended up having to put down that one & 2 other he owned. AFTER spending lots of money trying to save them.

Culling is a must..

I've heard of many different treatments and none have worked in the past.

If u bred a male to a few females and the females abort the pups u probably got it but to be sure have blood work done.

The stud owner provides the opportunity of minimum one and maximum two breeding's on set day of breeding (if possible, on the agreed date and time set appointment of breeding) (only during day light hours 07h00 – 17h00).

Once the male has mounted the female successfully as stipulated or even with the female is not ready and within the full-time frame given as agreed spend (07h00 – 17h00) and given the opportunity, will be agreed, and excepted by both parties that the stud's duties and obligations regarding this agreement would have been fulfilled.

No refunds are offered if the breeding does not happen for whatever reason.

Agreed beforehand that there are no refunds on the stud fees if the breeding does not happen – know this and do not be disappointed.

The option of artificial insemination could be decided on beforehand.

The owner of the female dog might rather decide on artificial insemination and then **prearrange** all with the stud owner's local vet – naturally all expense will be for the account the owner of the female dog -plan for pre vet consultation for any tests the Vet need to run on the male and female dog.

Guarantee of a litter.

It should have also been agreed that the owner of the stud cannot guarantee a litter – even if the mating was successful. Proof of previous litter with that stud dog in question and contact information for owners of such pups fathered by this stud dog in question could be given and normally such a stud's offspring will be seen at the owner of the stud dogs yard. **That's it ...Gawie Manjaro - MK.**
